MPS is also responsible for administering issues related to immigration, household registration and resident identity cards, guarding specific personnel and important places, managing assemblies, processions and demonstrations, supervising and administering the security supervision of public information networks, guiding and supervising the public security work of state organs, public organizations, enterprises and institutions and key construction projects, and guiding the public security work of public security committees and other mass organizations.

<p>State Immigration Administration (Entry and Exit Administration) (国家移民管理局、出入境管理局) Xu Ganlu 徐甘露 Formulates immigration policies and organize their implementation; takes charge of the management of entry and exit ports, and the examination of ports documents; administers issues related to foreigner's residence in China, and coordinates the repatriation of illegal immigrants; undertakes international cooperation in the field of migration.</p>
